### Day of the Endangered Lawyer

#### Who are we?

The International Observatory of Endangered Lawyers (OIAD) is an initiative of the French National Council of Bar Associations (France), the Paris Bar (France), the Consejo General de la Abogicia Espanola (Spain) and the Consiglio Nazionale Forense (Italy).

Launched in 2015, the Observatory aims to protect lawyers who are threatened as a result of their professional practice, as well as to denounce situations that violate the rights of the defense. It aims to articulate itself in the landscape of protection mechanisms geared towards lawyers in general and human rights lawyers in particular, complementing existing mechanisms and working closely with established networks.

By bringing together as many Bar Associations and organizations as possible, the Observatory acts as a key international player in the defense of at-risk lawyers.

#### Why such a day on 24th of January?

Since 2009, the European Democratic Lawyers' Association has been organizing, in collaboration with the "Day of the Endangered Lawyer" Foundation and other lawyers' and bar associations, each year, the Day of the Endangered Lawyer in as many cities, countries and continents as possible.

The purpose of this international day is to focus the attention of civil society and public authorities on the situation of lawyers in a particular country in order to raise awareness of the threats faced by lawyers in the exercise of their profession.

After the situation of lawyers in Iran, Turkey, the Philippines, the Basque Country, Honduras, China and Egypt, the Day of the Endangered Lawyer 2020 will be dedicated to the situation of lawyers in Pakistan. It will be dedicated to Pakistani lawyers to testify to the seriousness of the situation in that country.

#### Things you can do to celebrate the Day of the Endangered Lawyer:

#### 1. PROMOTE THE WORLD DAY ON SOCIAL MEDIA

Write an article or spread articles from other organizations related to the Day of the Endangered Lawyer on its website.

Use Twitter to spread even more widely and in particular with the help of **hashtags**, by **retwitching** the different twitts of other organizations/bars, by **tagging** political/diplomatic/NGO figures.

#### 2. ORGANIZE AN EVENT: A DEMONSTRATION, A SIT-IN

Gather in front of the embassy of the country concerned by the World Day and/or meet in front of the courthouse or the Bar Association.

If the demonstration is planned in a public place, the authorities must be notified in advance.

Plan banners, placards, brochures to inform about what World Day is.



# 3. JOIN A MOBILIZATION ORGANIZED BY OTHER OIAD'S MEMBERS

Each member informs and shares his or her event to eventually facilitate the other bars to join them.

#### 4. DISPLAY A BANNER

Make a request to the authorities in advance.

#### **6.** ORGANIZE A CONFERENCE

Prepare several months in advance the presence of a personality for testimony/specialists on the chosen country, lawyers in exile or on the more general question of lawyers in danger.

Communicate on the event to bring as many people as possible.

Invite media to give more visibility to the event.

#### 7. ORGANIZE A CULTURAL EVENT

Organize a photo exhibition, a play, the screening of a film on the issue of lawyers in danger and the defense of the defense;

Contact artists according to the theme of the day;

Invite media to cover the event.

#### 8. CALL ON MEDIA TO COVER THE EVENT

Write a press release.

Contact journalists/the press to cover the event and give more visibility to the actions carried out.
